When to use the form?

You should complete this form if you have an inactive low-balance account with legalsuper and want this account to remain with legalsuper. An inactive low-balance account is when:

- no amount has been received to your account for your benefit within the last 16 months i.e a contribution or roll-in;
- the account balance is less than \$6,000;
- · you have not met a prescribed condition of release;
- there is no insurance on the account; and
- · in the last 16 months:
 - you have not changed your investment options or insurance coverage;
 - you have not made or amended a binding beneficiary nomination.

If your inactive low-balance account remains with legalsuper, your retirement savings will continue to be subject to fees and charges.

legalsuper is required to report and transfer inactive low balance accounts to the Australian Taxation Office (ATO) unless you tell us in writing that you do not want this to occur.

Once we receive this notice, you advise legalsuper that you want your legalsuper account to remain open and not be transferred to the ATO. We will then take the required actions to implement your request. This notice is valid for 16 months from when it is received by legalsuper.

For information relevant to your account if it remains active with legalsuper, please refer to the Product Disclosure Statement (PDS).

Things you should know

legalsuper needs to receive this form 30 days before the statement dates (31 October and 30 April each year), otherwise, legalsuper is required to report and pay your account to the ATO.

Your correctly completed notice will only be effective for 16 months of the date when legalsuper receives it. If your legalsuper account satisfies the inactive low-balance account criteria after the expiry of the 16 months, you will need to complete a new Inactive low-balance account notice form.

If your account remains with legalsuper, it will continue to be subject to fees and charges.
